FOREWORD

Union Christian College (Autonomous), Aluva, with a proud legacy spanning over 104 years, stands as a distinguished institution of higher learning in India. 1921 by four young visionaries and educationalists who were old students and teachers of Madras Christian College, Prof K C Chacko, Prof C P Mathew, Prof A M Varkey and Prof V M Itteyera, with a vision of holistic development of the students. The institution began its academic journey with a junior intermediate course, enrolling 64 students and employing 6 teachers in a rented building. Later, it was shifted to Kacheri Malika, donated by the Maharaja of Travancore. From its inception, the College has consistently upheld a commitment to academic excellence, holistic development, and a deep-rooted social consciousness.

Our journey through the decades has been marked by continuous growth and academic distinction. The college was recognised by the R. Sankar Award instituted by the Government of Kerala for the best Special Grade Arts and Science College in the State for the Year 2000-2001. The institution was the first in Kerala to receive a five-star rating from NAAC in 1999, and in 2024, the college was accredited with an A++ grade in the 5th Cycle of NAAC accreditation. The commendable positions in national rankings NIRF 97th rank in 2022 and 77th rank in 2023, and 12th ranking in KIRF 2024, bear testimony to our unwavering dedication to quality education and institutional integrity.

Union Christian College offers a wide spectrum of programmes across both aided and self-financing streams, designed to meet the evolving educational needs of our diverse student body. The college now has 18 UG, 14 PG programs and 10 research centers, and 1 interdisciplinary research centre. 1. ONLINE APPLICATION & ADMISSION**A. Application Submission Guidelines**

Candidates seeking admission to the **Pndergraduate Programmes** at *Union Christian College, Aluva (Autonomous)* for the academic year **2025–26** are required to submit their applications **exclusively through the online portal**. The online application must be completed **on or before the last date specified** in the **official admission schedule**, which is published on the College website. Applicants may access the registration portal by visiting: www.ucccollege.edu.in

Please note that **only applications submitted online within the stipulated timeframe** will be considered for the admission process.

1. Applicants are advised to complete the online application using a laptop or desktop computer to ensure optimal functionality and a seamless registration experience.
2. Each candidate may select up to six programme options while applying. Selection of a minimum of three programmes is mandatory.
3. The application fee is ₹300/- for General category candidates and ₹150/- for SC/ST candidates. The application fee for management quota is ₹500/-. Please note that the application fee is non-refundable, under all circumstances.
4. Candidates applying under the Sports, Cultural, or Community quota must submit their applications through the online portal. For Community Quota applicants, a valid Community Certificate issued by the Village Officer/Parish Priest must be produced at the time of verification.
5. Candidates applying under the Sports or Cultural quota are required to submit a hard copy of the completed application form along with self-attested copies of relevant certificates to the College Office.
6. Candidates seeking admission under the Management Quota must apply online via the College Admission Portal along with supporting documents and Recommendation Letters.
7. Candidates are not required to send or submit a printed copy of the application form to the College Office.
8. All admission-related notifications and updates will be communicated through SMS and email to the registered mobile number and email address provided during the application process.

B. Requirements for Online Registration:

1. Review Official Documents before proceeding with the application, ensure you have thoroughly read the 'Instructions' and 'Prospectus' available on the college website.
2. Applicants must possess a valid email address and mobile number. If you do not have an email ID, create one and confirm its functionality before using it for registration.

3. Upload a recent passport-size photograph (taken within the last six months). File size: Must be between 60 KB and 100 KB. Upload a scanned image of your signature. File size: Must be between 60 KB and 100 KB
4. Upload clear scanned copies of the following:
5. Final mark sheets of your 10th and Plus Two (or equivalent) examinations
6. Certificates for claiming reservation benefits or bonus marks (such as those for NCC, NSS, Sports, Arts, etc.)
7. If applying under the NCC quota, compile and upload a single document that includes:
 - ✦ Participation certificate(s)
 - ✦ NCC 'B' or 'C' Certificate
8. Candidates applying under both Cultural and Sports quotas must compile all relevant certificates into a single file and upload it accordingly. **C. Online Registration Process:**
 1. New applicants must begin by clicking on the '**UG Registration**' button on the admission portal.
 2. After completing the initial registration details, your **username and password** will be sent to your **registered email ID** or via **SMS**. These credentials are essential for logging in to your account. Use the provided **username and password** to log in to your application portal.
 3. Complete the application form carefully. Ensure you upload the following documents where applicable:
 - ☐ Scanned **passport-size photograph** with **name and date**
 - ☐ Scanned **signature**
 - ☐ Scanned copies of all necessary **certificates** (e.g., academic, reservation, quota-related)
 4. If applying under the **community quota**, select '**Reservation under State Government**' in the relevant section.
 5. Pay the **application fee online** using any of the following methods:
 - ✦ Debit/Credit Card
 - ✦ Net Banking
 - ☐ **UPI**
 6. Double-check all entered information carefully.
 7. Most sections can be edited during subsequent logins **except** for the **final marks entry page**.
 8. **No changes will be allowed after clicking the 'Submit' button.**

9. Always **log out** from the admission portal before leaving the computer to ensure your data remains secure.
10. **Any attempt to create a false or unauthorized registration by an individual or institution will attract punitive action as per applicable rules and regulations.**

IMPORTANT

- Applicants **should not enter** the marks obtained for vocational subjects since those are not used in Index Mark (Rank Mark) calculations (except for Pre-CBCSS Model II candidates).
- Applicants **should enter the Grades and Credits** obtained for each subject.
- Do not enter ‘Marks’ obtained, unless ‘Pre-CBCSS’ is selected as the qualifying examination pattern.

D. Admission Process

1. Rank lists for each programme will be prepared in accordance with the rules outlined in the **college prospectus**.
2. Candidates are advised to regularly check the **provisional rank lists** published on the **college website** and **notice board**. Any discrepancies must be reported before the **correction deadline** mentioned in the prospectus.
3. Final rank lists will be published on the **college website** and notice board on the specified date. Admissions will proceed based on the final rank list after incorporating all necessary corrections.
4. Candidates must regularly visit the college website for updates regarding **admission schedules** and related changes.
5. **Admission memos will not be sent by post.** Notifications will be sent via **email** and/or **SMS**. Please note: If your mobile number has **DND (Do Not Disturb)** enabled, you may not receive SMS alerts from the college.
6. Eligible candidates will be invited for **original certificate verification** in the order of their appearance on the rank list.
7. The college will **verify all original documents** at the time of admission.
8. Candidates called for certificate verification must report to the college on the scheduled date. Be prepared to pay the **prescribed fee**, including **caution deposits**, if admitted. Failure to report or remit the required fee will result in the candidate being marked as **‘Not Joined’**, and no further claims for admission will be entertained.
9. Candidates claiming **reservations or bonus marks** must present the **original supporting documents** during verification.
10. Always mention your **application number** in any communication with the college office.

3. ELIGIBILITY FOR ADMISSION

3.1. Academic eligibility should be satisfied as on the last date of submission of academic data. No candidate will be admitted to the PG Programme unless he/she possesses the qualifications and minimum requirements thereof, as prescribed by Mahatma Gandhi University from time to time.

3.2. If an applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she had indulged in ragging, admission shall be denied or he/she will be expelled from College.

3.3. (i) Candidates should have passed the corresponding Degree Examination under the 10 + 2 + 3 pattern with one core/main subject and two complementary/subsidiary subjects from any of the Universities in Kerala or of any other University recognized by Mahatma Gandhi University as equivalent thereto for admission, subject to the stipulation regarding marks.

(ii) Candidates who have passed Degree examination with Double or Triple main subject and candidates who have passed the Degree Examination in Vocational or Specialized Programmes are also eligible for admission. However, they have to submit copy of the Equivalency/Eligibility Certificate from Mahatma Gandhi University, stating that, their Qualifying Examination is recognized for seeking admission to the relevant P.G. Degree Programme(s) as applicable, at the time of admission. This provision is not applicable in the case of those applicants who have passed their qualifying examination from Mahatma Gandhi University, Kottayam.

(iii) The minimum requirements for admission to PG Programmes are:

75% of the total seats would be reserved for those who have taken English as Optional (Main) concerned under Part III for the BA Degree Programme.

OR

Candidates should have passed any graduation degree (e.g: B.E/ B.Tech./B.Sc/ B.Com./ B.A/ B.Voc.etc.,) preferably with Mathematics at 10+2 level or at Graduation level from a recognized university.

OR

Candidates with such degrees awarded by the Mahatma Gandhi University or any other degree recognized as equivalent to the above listed courses by the Mahatma Gandhi University also is eligible

to apply. In such cases candidates should obtain at least 50% marks(45% marks in case of candidates belonging to reserved category) in the qualifying examination.

Relaxation in Marks in the qualifying examination:

- i) Kerala Scheduled Caste/Scheduled Tribe Category: The minimum requirement for admission is a pass in the qualifying examination for the Kerala Scheduled caste/Scheduled tribe category.
- ii) SEBC Category: A relaxation of 3% marks in the qualifying examination from the prescribed minimum is allowed.
- iii) OEC Category: A relaxation of 5% marks in the qualifying examination from the prescribed minimum is allowed.
- iv) Persons with Disability category: A relaxation of 5% marks in the qualifying examination from the prescribed minimum is allowed.

14. Master of Business Administration

A pass in any Bachelor's Degree Examination of Mahatma Gandhi University or an equivalent degree of any other Universities duly recognized by Mahatma Gandhi University with not less than 50% marks in the aggregate for all parts of examination or a Master's Degree examination with 50% marks in aggregate. Under grading system, C Grade of Mahatma Gandhi University or equivalent thereto from other recognized Universities with not less than 50% marks in aggregate is required to become eligible for admission. Under any circumstances, it shall be the responsibility of the Director / Principal to ensure that a candidate is having 50% marks in aggregate in order to become eligible for admission. For SC/ST students, a pass in any Bachelor's Degree examination is needed. Reservation rules are applicable as per Government of Kerala norms for eligibility and admission.

4. RESERVATION OF SEATS

Seats available for aided Programmes and Self-Financing Programmes in the College are under categories of **Merit seats, Community seats, Management seats and seats under reservation.**

Types of Reservation: Out of the total seats available for various PG Programmes; seats will be reserved for different categories under the following main items.

- i. Reservation for International Students
- ii. Reservation for Nominees.
- iii. Reservation for Persons with Disabilities.
- iv. Reservation for Orphan students
- v. Reservation for Transgender candidates
- vi. Special Reservation.
- vii. Mandatory Reservation.

i. Reservation for International Students

10% additional seats shall be created over and above the sanctioned strength and added to the total merit seats exclusively for the purpose of accommodating international students. These seats shall not be filled up with other candidates. The students who seek admission in this category should first apply online and submit the print out of the online application to the college. **ii. Reservation for Nominees:**

An additional seat for each Programme shall be created exclusively for the purpose of accommodating **students sponsored by the Union Territory of Lakshadweep**. This seat shall not be filled up by other candidates.

Reservation of Seats for Malayalee students from Andaman & Nicobar Islands: An additional seat for each Programme shall be created exclusively for the purpose of Malayalee students from Andaman & Nicobar Islands. This seat shall not be filled up by other candidates (**U.O. No. 6199/AI/2016/Acad dated 23.11.2016**). **iii. Reservation for Persons with Disabilities (PD):**

Person with Disability' means a person suffering from not less than 40% of any disability as certified by a Medical Board constituted for this purpose. Candidates who have a minimum of 40% disability alone will be eligible for this quota. A relaxation of 5% of marks in the qualifying examination from the prescribed minimum is allowed. Candidates seeking admission under Differently Abled category should submit the "Certificate of disability", issued not earlier than 5 years prior to the submission of application, by the District Medical Board or bodies of higher status, certifying the degree of percentage of disability. The Permanent Disability Card issued by the State Government is also considered. Based on the details furnished in the online application, candidates will be provisionally included under the "Differently Abled" category. If candidates are not available in a particular category, the seats shall not be filled from any other categories.

5% seats of the sanctioned strength shall be created over and above, exclusively for candidates with benchmark disability (as per clause 32 (I) of chapter VI, The Rights of Persons with Disabilities Act, 2016). If candidates are not available in a particular category, the seats shall not be filled from any other categories. The rank list under this category will be based on merit and physical suitability, and not on the basis of the degree of disability. One additional seat for PG programmes will be created over and above the sanctioned strength for accommodating students suffering from autism/intellectual disability/specific learning disability/mental illness as per **GO No. 229/2023/HEDN dated 02.05.2023**.

No reservation of seats is allowed for Blind candidates for programs under the Faculty of Science. Selected candidates under PD quota should report directly to the College before the last date for their admission as per admission schedule. **iv. Reservation for Orphan students**

Two additional seats (Male-1 & Female-1) for each programme shall be created over and above the sanctioned strength exclusively for orphan students. This seat shall not be filled up by other candidates as per the **G.O. No. 3149/AC A 1/2024/MGU**

v. Reservation for Transgender candidates: Two additional seats for each Programme shall be created exclusively for the purpose of accommodating students under transgender category as per the **G.O.(Ms)No.153/2018 HEdn dated 03.07.2018**.

vi. Special Reservation:

The seats reserved under **Sports Quota** and **Cultural Quota** come under this category. Selected candidates under these quotas should report to the College before the last date for their admission as per admission schedule.

Sports quota: -

Age Limit: Upper age limit for applying through Sports quota is 25 years.

The following norms are prescribed for admission under sports quota.

1. One seat for every 20 seats for M.A., M.Sc., M.Com Programmes with permission for interchangeability
2. Where the number of seats is less than 20 for a subject, the seats may be pooled together, M.A., M.Sc., and M.Com being treated separately. Where the number of seats, after pooling, exceeds multiples of 20, an additional seat can be earmarked, if the excess number is 15 or more.
3. Where the number of seats is still less than 15 after such pooling, all PG Programmes may be pooled together.
4. After such pooling, if the number of seats exceeds multiples of 20, an additional seat can be earmarked if the excess number is 15 or more.
5. A minimum of one seat may be given if there are no sufficient seats.

The applicant for admission to the Sports quota should have represented at least the College in the Inter Collegiate Competitions. Preference shall be given to Sportsmen who have represented the State/University over the sportsmen who have represented the District/College. Performance in any year during the Under Graduate Programme only will be taken into consideration.

The following guidelines shall be followed in determining merit in sports and games for admission to the PG Programmes

Points shall be awarded to the first (Winner or the Winning Team), Second (Runners up or Runners up team), third (third place) and participation as:

The selection of candidates under the category will be based on the proficiency in sports/games.

- i. A person can score points only in one category.
- ii. The highest score will be counted iii. Where bracketed, scores in other categories will be counted
- iv. Where still bracketed, Priority will be given in the order of merit i.e.; 1st, 2nd, and 3rd place respectively.
- v. Those with a greater number of achievements in the same level will be placed above the others (a greater number of 1st places, a greater number of 2nd places and so on). The selection of candidates under the category will be based on the proficiency in sports/games. vi. Individual achievements will be ranked above team achievements.
- vii. A new record is created; he/she will be given priority. If the tie could not be resolved by any of the above-mentioned sports achievements, the index marks based on the qualifying examination shall be considered for breaking the tie. ix. Performance in any year during the Under Graduate Programme will be taken into consideration.
- x. The students admitted in Sports quota shall mandatorily be available to represent the College/University in the Inter-collegiate/Inter- University competitions unless specifically exempted by the Principal of the college or Vice-Chancellor/Director of Physical Education, Mahatma Gandhi University.

Addendum

1. Only the events which are having Intercollegiate competitions in Mahatma Gandhi University alone will be considered for Sports Quota admission.
2. Approved World competitions means the competitions organized by the International Apex Bodies of the concerned discipline and in which the national Teams are sponsored by the National Apex Bodies and cleared by Sports Authority of India/ Government of India.
3. The National Championship means the championships conducted by the National Apex Bodies of the concerned discipline. District Competition means revenue district competition conducted by district association in respective sports.
4. Individual games /event means a game/event in which individual performs alone.

5. When a candidate has number of achievement in a sports /different discipline his/ her best achievement will be taken in to consideration.

6. For team events, Colleges should upload the events they wish to choose in the beginning of each academic year.

Cultural Quota: -

1. One seat for every 20 seats for M.A., M.Sc., M.Com Programmes with interchangeability.
2. Where the number of seats is less than 20 for a subject, the seats may be pooled together, M.A., M.Sc., and M.Com being treated separately. Where the number of seats, after pooling, exceeds multiples of 20, an additional seat can be earmarked, if the excess number is 15 or more.

The selection will be made from among the applicants for the cultural quota on merit as follows

In the absence of applicants who do not secure 1st, 2nd and 3rd and 4th places candidates with 'A' grade will be considered for admission. The selection of candidates under the category will be based on the proficiency in cultural events only.

- i. A person can score points only in one category.
- ii. The highest score will be counted
- iii. Where bracketed, scores in other categories will be counted
- iv. Where still bracketed, person who was the University athletic champion will be given 3 extra points.
- v. Performance in any year during the Degree Programme in Mahatma Gandhi University will be taken into consideration.

A person can score points only in one category and the highest score will be counted.

viii. Mandatory Reservation

The seats for each Programme will be distributed as per the existing pattern of the Mahatma Gandhi University as given in table below:

5. CLAIMS FOR MANDATORY RESERVATION AND CERTIFICATES TO BE PRODUCED

- (i) Claims for Mandatory Reservations must be made by a candidate at the time of submission of application, with supporting documents as required.
- (ii) The claims for mandatory reservation once made in the Application form cannot be altered by the candidate under any circumstances.

Claim for Reservation under Kerala Scheduled Castes/Kerala Scheduled Tribes Quota

- (i) Candidates claiming reservation under Kerala Scheduled Castes/ Kerala Scheduled Tribes

Quota should obtain caste/community certificate from the revenue authorities concerned. The candidates who are reconverted to Hinduism from Christianity of Scheduled caste origin should produce community certificate from Village Officer along with a copy of the gazette notification.

- (ii) **Claim of OEC candidates against the un-availed seats of SC/ST candidates:** Other Eligible Community (OEC candidates) who claim allotment to the un-availed seats, if any, under SC/ST quota should furnish community and income certificates obtained from the revenue authorities concerned. Those OEC candidates whose annual family income is up to Rs.8 lakhs alone are eligible for such seats.

They are exempted from payment of fee at the time of allotment to PG Degree Programmes under Government/Community quota irrespective of annual family income as per **G.O (Ms) No.36/07/SCSTDD dated 03.07.2007. They should produce Community Certificate from the Revenue Authorities concerned.**

- (iii) **Claim for Communal reservation under ‘Socially and Educationally Backward Classes’**

(SEBC): Reservation of seats to the Socially and Educationally Backward Classes will be in

accordance with the provisions contained in G.O. (P) 208/66/Edn. dated 2.5.1966, as amended from time to time.

- (i) Candidates belonging to Socially and Educationally Backward Classes as per G.O. (P) 02/2018/BCDD dated 08.03.2018, who belong to the non-creamy layer are eligible for reservation under this category. The non-creamy layer certificate should have been issued not earlier than 12 months prior to the submission of application.
- (ii) Candidates belonging to Ezhava, Muslim, Other backward Hindus, Latin Catholic other than Anglo Indians and Other backward Christian communities, claiming reservation under SEBC Quota should invariably produce both ‘Community’ and ‘Income Certificates’/non-creamy layer certificate

obtained from the Village Officer concerned. The self-attested copy of the above certificates should be attached with the application. Candidates who belong to the non-creamy layer are eligible for reservation. The seats unveiled by SEBC category candidates will be allotted under open quota.

OTHER GENERAL RULES FOR MANDATORY RESERVATION:

(i) The seats un-availed by the SC candidates will be diverted to ST candidates and vice versa. The unavailed seats reserved for SC/ST shall be re-notified through print media. If such seats are remaining vacant even after re-notification, these shall be filled as detailed below:-

The unfilled vacancies shall be filled from candidates belonging to OEC, and in their absence candidates belonging to SEBC. The seats that further remain unfilled shall go to community quota.

6. PREPARATION OF RANK LIST

Under Pre - CBCSS pattern, the rank list of P.G degree Programmes will be prepared on the basis of the marks obtained in the qualifying examination in part III subjects unless otherwise mentioned, standardized to 1000. The index mark is arrived at after adding/deducting weightage, bonus marks and handicap marks, if any.

Under CBCSS and CBCS pattern, the CGPA/CCPA secured for Part III Core group (Core + Complementary courses) unless otherwise mentioned shall be converted into marks out of 1000. The index mark is arrived at after adding /deducting weightage, bonus marks and handicap marks, if any.

Wherever letter grades are given for the qualifying examination, the candidate should produce the relevant document so that the grades can be converted into actual marks. In the case of grades where marks range is given, the mid value will be taken for computation of index marks.

Bonus Marks

The Bonus marks will be awarded as follows:

(i) Bonus marks of five will be awarded to candidates with NCC certificate for admission to all Programmes. An additional bonus mark of 5 each will be given to 'B' and 'C' Certificate holders in proof of their high proficiency. For NCC candidates the bonus marks will be awarded on the basis of the NCC certificates signed by the Director and issued by the Directorate provided the candidates have secured at least 75% attendance after having participated in NCC activities during the period of study for Undergraduate Programmes. ***The Claim of those candidates who have participated in NCC/NSS activities prior to the University level Programme i.e. Higher Secondary / Plus Two / Vocational Higher Secondary etc. will not be taken into account for awarding bonus marks.***

(ii) Bonus marks of 5 shall be awarded to NSS Certificate holders. In respect of NSS candidates the bonus marks will be awarded on the basis of NSS certificates signed by the Vice- Chancellor or the Pro-Vice-Chancellor and issued to volunteers who have completed 240 hours of work within a period of 2 years of undergraduate study immediately preceding the P.G Programmes for which admission is sought.

(iii) **The benefit of bonus marks can be scored by a candidate only under one category i.e.; either NSS or NCC.**

(iv) A bonus of 15 marks will be awarded to the Ex-servicemen applicants and widows and children of Jawans and Ex-service men seeking admission to the P.G. Programmes. Applicants in this category should invariably produce the certificate in support of their claim at the time of admission. The certificate should be obtained not earlier than six months from the last date of submission of application from the military authorities or state/Zilla Sainik Welfare Officer to the effect that the applicant is the son/daughter of ex- service man or an ex-service man himself/herself.

(v) Bonus marks will be added only if the candidate has obtained the prescribed minimum qualifying marks in the qualifying examination while calculating the index marks.

Deduction in Marks

Deduction will be made from the total ranking marks for those candidates who had availed more than one chance in passing the qualifying examination as detailed below:

(i) Handicap mark of 5 will be deducted from the total rank marks for each additional appearance he/she has taken for completing the qualifying examination. *Number of chances means the number of chances for passing any part of the qualifying examination excluding cancellation.*

7. CALCULATION OF INDEX MARKS

Index mark is calculated after adding /deducting the weightage, bonus marks and handicap marks, if any. For details regarding the weightage of marks for various Programmes, please refer to sections 3 and 6 of this prospectus relating to the eligibility for admission and bonus marks. The process of index mark calculations described below is as per Mahatma Gandhi University norms and is subject to change in accordance with changes in the University norms.

Resolving of Tie:

In the case of more than one candidate obtaining equal index marks (including weightage/deduction, if applicable), the candidate who has scored more marks in Part III Main

will be placed higher in ranking. If the tie persists the candidate who has scored more marks in Part I common courses/ papers English will be placed higher in ranking and if the tie still persists, the marks scored in Part II common course/additional language will be considered. If the tie still persists, the age of the candidates will be taken into account, the older being placed higher in the ranking. Even after this exercise, if the tie persists, the alphabetical order of the first name of the candidates will be taken into account.

Rounding of marks of 0.5 and above to the highest figure will not be done while calculating the percentage of marks for minimum eligibility.

8. FEE TO BE REMITTED

1. Application fee is Rs. 300/-. If a candidate is applying for more than one programme, an additional fee of Rs 100/- per programme shall be remitted. For SC/ST candidates, the application fee is Rs.150/-. Additional fee is Rs 50/- per Programme.

5. Eligibility Certificate from Mahatma Gandhi University, in the case of candidates who have passed their qualifying examination from Boards/Institutes/Universities not listed by the Mahatma Gandhi University.
6. Migration Certificate, if applicable.
7. Caste Certificates proving eligibility for reservation and one self-attested copy of the same.

8. Community Certificate along with income certificate (as per Government rules) from the revenue authorities concerned, to the effect that annual family income of all members of family from all sources taken together is less than Rs. 8 lakhs in the case of SEBC candidates who claim reservation under SEBC category. The income certificate should not have been issued earlier than 6 months prior to the submission of application.
 9. Candidates seeking reservation under Christian community should produce certificate from the village officer concerned and one self-attested copy of the same.
 10. Candidates who wish to avail of bonus/weightage marks and those who come under sports/cultural/PD quotas must produce relevant certificates in original and one self-attested copy of the same.
 11. Four passport size photos of the applicant (taken within six months)
 12. Any other documents found necessary by the Principal.

RAGGING IS A CRIME

Ragging is prohibited in this Institution

What is Ragging?

Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

Administrative action in the event of ragging:

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here in under:

The Anti-Ragging Committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad

The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely;

- a) Suspension from attending classes and academic privileges.
- b) Withholding/ withdrawing scholarship/ fellowship and other benefits
- c) Debarring from appearing in any test/ examination or other evaluation process. d) Withholding results.
- e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.

- f) Suspension/ expulsion from the hostel.
- g) Cancellation of admission.
- h) Rustication from the institution for period ranging from one to four semesters.
- i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
