Sub: RESTRICTED ENTRY OF AUTOMOBILES Reg:

Ref: Circular No.02/UCC/BP-G1/2017 dated 05.06.2014

As per the Circular dated 05.06.2014, the institution reinforces the rules and norms regarding the restricted entry of automobiles beyond a point in the campus to students.

As part of this resolve, the teachers and students are directed to make restricted use of automobiles in the college premises. To accomplish the same, the students shall utilize the public transport facilities or pooling facility. The bicycles available in the campus shall also be used by staff and students to commute in the campus and to nearby places.

The institution also adds the following norms to enforce restricted automobile entry.

The staff shall resort to carpooling system to minimize the entry of automobiles in the college campus. The staff and students are also encouraged to use electric and battery powered vehicles.

The circular will come to effect from 15.10. 2021.
